- WHITE ~ GREEN need (3) BOARDS and (3) TECHNIQUES
- BLUE ~ DEPUTY need (4) BOARDS and (4) TECHNIQUES

#### BLACK BELTS

- CAN DO THEIR OWN ROUTINE
- NEEDS (4) BOARDS and (2) TECHNIQUES and (2) FREE STYLE TECHNIQUES
- BOARD SET-UP TIME IS UP TO 30 SECONDS WITH JUDGES
- TWO CHANCES FOR EACH BREAKING
- CHILD BOARD (3~13yrs) ADULT BOARD (14yrs & up)
- ADULT BOARD (14yrs & up)

(Once the start signal is given, each competitor has 15 seconds to complete the Speed Breaking competition.)

- In the Skip Roundhouse Speed Breaking event, the minimum distance between the two breaking stations or obstacles will be the competitor's arm span, measured fingertip to fingertip.
- In order to count a broken board as a successful break, the competitor must use the top of the foot to break the board.

  (If any other part of the foot is used, or if the foot is not in the correct position when the board is broken, the judge will NOT count the board as a successful break.)
- All boards must be held at a 45 degree angle.
   (Any board broken that was not held at this angle will not be counted as a successful break.)

(The winner of each division will automatically be declared Grand Champion.)
